In addition, notwithstanding the terms the terms of the Protective Order, one counsel for Plaintiff and one counsel for Defendants may retain one copy of all documents produced or filed with the Court in this case. The terms of the Protective Order shall continue to apply to such copies.

IT IS FURTHER ORDERED that this Court shall retain sole and exclusive jurisdiction of this case with regard to injunctive relief, the Protective Order and the settlement between the parties.
